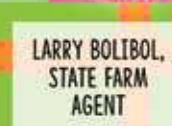

MESSAGES FROM ELECTED OFFICIALS

A Message From SENATOR DONOVAN M. DELA CRUZ

Aloha,

This past legislative session was challenging like no other due to the disruptions caused by COVID-19. Despite this, my colleagues and I worked hard and diligently to pass significant measures that largely impact the community. These range from funding community projects to bills that will benefit our business owners and students.

One of the challenges was ensuring that our State budget addressed the State's current fiscal situation and economic challenges following the COVID-19 pandemic. The budget bill we passed will not only ensure the efficacy of government, but also provide funding to our community and schools so that our schools can recover from the effects of the pandemic.

More than 3,000 measures were reviewed this past session. After months of hearings and votes along with negotiations between the House and Senate, over 230 bills were agreed upon and sent to the Governor's office for him to consider. Of the bills awaiting his signature, there are 2 major initiatives that will assist local businesses and those on unemployment. I have listed them below:

Payment of Unemployment Insurance Loan to Assist Local Businesses

At the start of the pandemic, Hawaii businesses were required to close their doors. This resulted in mass layoffs, loss of revenue and customers. While businesses are now on their way to recovery, there is still more we can do to assist them. This is why the Legislature is supporting local businesses by paying the \$700 million unemployment insurance (UI) loan. This will provide the much-needed relief to businesses in our community.

Supporting a New UI Call Center for Claimants

The legislature is supporting \$105 million to start a new UI call center which will expand the Department of Labor and Industrial Relations' capacity to accept appointments with claimants. It will also provide additional staff to examine claims and resolve issues so claimants can receive their payments in a timely manner.

My office also continues to work on projects that benefit Mililani families. This year we will reach a major benchmark on October 7, 2021 as we get closer to transitioning Mililani Middle School from a multi-track calendar to a single-track calendar.

New Building at Mililani Middle School Nears Completion

We are less than 3 months away from completing the construction of the 15-classroom building which will transition Mililani Middle School

from multi-track to single-track! This project began as an idea and a simple site visit to the campus led by Principal Elynne Chung in 2014. By providing the full funding of \$23 million in 2017, we were able to implement the project. As schools return to in-person learning, students at Mililani Middle School will be able to benefit from the transition starting SY 2022-2023.

Finally, I want to say thank you to the Mililani community for allowing me to serve as your Senator. Despite the challenges and difficulties, it was rewarding to know that the decisions we made this legislative session will help us to address the concerns in the community and positively impact our communities.

A Message From SENATOR MICHELLE KIDANI

Aloha Mililani Community,

After the immense challenges of the last year, 2021 offered a welcomed opportunity to rebuild. I want to thank you all for your efforts in helping us through these challenges. We started the year off with uncertainty, but made much progress along the way. This began with the first vaccine roll-out in December and January to combat the second surge in early 2021.

One of our primary focuses of the 2021 Legislative Session was tackling the massive budget deficit due to revenue shortfalls. The Governor's proposed 10% program review cut to education would have resulted in thousands of DOE staff being laid off. My priority was to alleviate the school budget cuts to the greatest extent possible, ensuring that students could return to a safe school with teachers and staff prepared to welcome them back.

As the Session progressed, our hope became reality as larger vaccine roll-outs took place throughout the state and cases decreased. Mahalo to MTA for allowing the use of Rec 5 for vaccinations. Additional Federal Relief monies came by way of the American Rescue Plan Act, which provided \$1.6B to the State and an additional \$412M to the Department of Education. Additional funding also went directly to the four counties. This funding offered invaluable support to local families and businesses, helping them get back on their feet after a devastating year.

We are so grateful to have ended our Legislative Session with a balanced budget, with the Legislature restoring funding to critical areas like education, social safety net programs, and assisting small businesses. We added money to restore more Weighted Student Formula (the primary funding source for schools), as well as more funding for programs targeting learning

loss and the reopening of our schools. Because of the unprecedented levels of unemployment benefit payments paid out last year due to the shutdowns, the State took out a \$700M Unemployment Insurance Loan. However, the repayment of this loan would have fallen to our businesses to repay at a time when many are just starting to see recovery on the horizon. In light of this, the Legislature made the decision to repay this loan, rather than burdening our local businesses and potentially causing many to close for good.

I am also pleased that despite these difficult financial times, myself and the other Mililani legislators managed to secure \$3.5M for the design and construction for a much needed expansion of the Mililani High School administration building. We are also excited to share that \$3M has been secured for Kipapa Elementary School's design and construction of a covered playcourt and other related improvements to provide shade and shelter for its students.

In closing, I'd like to wish our students and educators a wonderful end to their school year. My deepest aloha and congratulations to our Mililani High School graduating class of 2021! I was so proud to celebrate our graduates on May 16th as we cheered on 600 seniors as they entered Aloha Stadium. It was so inspiring to see friends, family and community members gather to celebrate the successes of these 600 graduates, including 80 Valedictorians, 28 Early College Program graduates, 5 National Association of Student Councils Gold Council of Excellence awards, 23 Seal of Biliteracy recipients, 7 AP Capstone Certificate & Diploma honors as well as various scholarship and academic awards. These students have truly shown incredible dedication and resilience over the last 2 years to finish their high school years strong despite their many challenges!

To the Mililani High School class of 2021, I am so proud of your strength and perseverance, and I know you will make tremendous strides in your professional careers and beyond! Congratulations and best wishes in this exciting next chapter—we are all behind you! Hail, hail, hail, Trojans!

A Message From REPRESENTATIVE LAUREN MATSUMOTO

Aloha Friends and Neighbors!

This past year has been a difficult year for many in our community. I have been encouraged to see how the community has come together through the hardships to help each other and get through this pandemic together. In our first full session back since the start of the COVID-19 pandemic, the legislature was back at the capitol newly equipped with personal protection equipment, virtual accommodations for both floor session and committees, as well

as various other important protocols to keep everyone safe and healthy. It was another busy and productive session where numerous items were addressed in the hopes of finding solutions for lingering pandemic-related issues, as well as planning for a brighter future for Hawai'i's residents.

Here are a few important updates I want to share with you from my office and the community:

E-Newsletter Sign Up

One of the top priorities of my office has always been to keep everyone informed on what is happening in the legislature and the community. The pandemic has made it even more clear that more frequent and timely communication is needed to keep you informed on the constant changes. I will still be sending traditional mail right to your door, however the budget I am allotted only allows for 4-5 pieces of mail for each person in the district per year. Additionally, traditional mail is often too slow in providing certain updates in a timely manner. Mid-Session Community Survey Results

Unemployment

Recently, the State of Hawaii's Department of Labor and Industrial Relations announced that those who have filed for Unemployment Insurance (UI) and have not heard back can schedule an appointment online to follow up on their claim. Appointments are scheduled three weeks out, and will be conducted via telephone or Zoom. To register, please visit <https://labor.hawaii.gov/ui/appointments/>.

If you are still having trouble please do not hesitate to reach out to my office. While I am not in charge of the unemployment office or the decisions they make regarding each account, my hope is that I can help expedite the process so that you are able to get the information you need. If you would like help with your unemployment applications please send me an email detailing the issue and include your full legal name, date of birth, and the last 4 digits of your social security number. Once we have this information my office will inquire on your behalf.

If you have any questions, ideas for legislation or concerns regarding the State of Hawaii and our community, please do not hesitate to reach out to my office. Now is a great time to get a head start on future legislation! By starting now, we can ensure that there are high-quality bills ready to be submitted early in next year's session. I look forward to what we can accomplish together in the coming months, both in the District and in preparation for next year's Legislative Session.

A Message From REPRESENTATIVE VALERIE OKIMOTO

Aloha Friends and Neighbors,

Thank you for the honor and privilege to serve as your voice and advocate in the state House of Representatives. The 2021 legislative session adjourned sine die on Thursday, April 29, 2021. For two days, the House voted on over 250 final versions of bills, which the Legislature subsequently sent to Governor Ige. The Governor has 45 days to review, approve or veto bills sent to him. The deadline to veto bills is June 21. Bills automatically become law without his signature after the 45th day.

Mililani is fortunate to have received over \$6 million this legislative session to improve facilities at our public schools. I am pleased to report that Mililani High School was awarded \$3.5 million for the Design and Construction to expand their administration buildings and various grounds and site improvements. I am pleased to report that Kipapa Elementary school was awarded \$3 million to design and construct a covered play court, including other

site and ground improvements.

The Legislatures primary focus in this session was to balance the State Budget. As many of you know, the State was weighing numerous department budget cuts, furloughs, and community program freezes to fulfill our constitutional obligation to have a balanced budget. With the most recent projection from the Council on Revenues, non-general fund scrutiny, and federal aid, we could avoid furloughs and significant budget cuts.

There were several bills that I voted against that would increase the cost of living, make it burdensome and more dangerous for law enforcement officers to do their jobs, further burden and restrict law-abiding firearms owners, and decriminalize the possession of marijuana. A handful of controversial bills were not passed this session and will more than likely be considered again in 2022. For example, the Legislature did not increase the minimum wage; this bill would further hurt our small businesses struggling to reopen due to unemployment benefits which have drastically disincentivized our workforce. It is time to reopen and get our communities back to work and bring in high quality high paying jobs that our people deserve.

Finally, The Hawaii State Legislature, in concurrence with the Executive Branch and the Judicial Branch, has agreed to defer the salary recommendations by the Council on salaries until December 31, 2022. We will review this matter when Hawaii's economy is back on its feet, and its people are back to work.

I want to send my sincere Mahalo to everyone who reached out to my staff or me to share their thoughts, opinions, and feedback on bills and resolutions that were considered this session. As your state representative in the people's House, I believe I voted for you and our entire community. While the legislative session has adjourned for the year, my office continues to work for you and Mililani. Please reach out and share your thoughts and ideas for legislation in 2022. A Message From REPRESENTATIVE RYAN YAMANE

Aloha,

I hope you and your family are doing well as we approach our beautiful, Hawaiian Summer! Congratulations to the many graduates of our community during this special graduating season. We are all very proud of you and hope that each graduate continues to make our Mililani community very proud in the future.

Mahalo for allowing me the opportunity to serve you and our community in the Hawaii State House of Representatives. My 2021 Legislative Newsletter summarizing many of the bills and our State's Budget will be coming to your mailbox soon. However, I would like to take this opportunity to update you on what I have been working on since the beginning of this 2021 Legislative Session.

District News: Improving Our Schools

I am proud to announce that our community will receive over \$6 Million in building projects for our schools and community infrastructure. These projects are vital to support our children's education, our families' safety and maintaining the special beauty of our Central Oahu communities.

- Kipapa Elementary School: Design and construction for the covered playcourt

\$3,000,000

- Mililani High School: Design and construction for administration building expansion

\$3,500,000

Total State Budget Funds to Mililani Community Schools in 2021-2022: \$6,500,000

I am pleased that the Legislature and State of Hawaii will be reinvesting over \$6 Million in our Mililani community schools. I will continue to represent our community and schools to include additional maintenance projects like these in our State Budget.

Rep. Yamane's Legislative Accomplishments

I am happy to share with our community the many improvements and bills that passed this year, which I was fortunate to achieve serving as the Chairman of the House Water, Land, and Hawaiian Affairs Committee:

- **HB1281 Relating to Emergency Medical Services**, a bill I introduced and championed that successfully passed the Legislature that established the transfer of duties, function, and powers relating to emergency medical services for the City and County of Honolulu from the Department of Health to the City and County of Honolulu.

- **SB628 - Relating to the Transition of the Oahu Regional Health Care System from the Hawaii Health Systems Corporation into the Department of Health**, a bill my office

vigorously worked on and championed that successfully passed the Legislature which commences the transfer of the Oahu Regional Health Care System from the Hawaii Health System Corporation to Department of Health. To conduct long-term care and substance abuse treatment at Leahi and Maluhia Hospital.

- **HB311 Relating to the Nursing Facility Sustainability Program**, a bill I introduced that extends the nursing facility sustainability program to 2024.

- **SB819 Relating to the Hospital Sustainability Program**, a bill my office vigorously worked on which extends the hospital sustainability program through 2024. Increases the amount of time hospitals have to pay the hospital sustainability fee.

- **HB313 Relating to Physician Workforce**, a bill I introduced to authorize funds from the John A. Burns School of Medicine special fund to be expended for loan repayments to physicians who commit to working in certain medically underserved areas as part of the Hawaii State Loan Repayment Program and Scholarships to qualifying medical students.

- **HB541 Relating to Health**, a bill I introduced that clarifies the duties of the Department of Health working group to evaluate current behavioral health care and related systems and identify the gaps in services, coordinate funding sources, and establish and identify outcome measures for persons experiencing behavioral health or substance abuse.

- **HB471 Relating to Behavior Analysts**, a bill I introduced to make the regulation of behavior analysts permanent.

- **HB1283 Relating to Health**, a bill I introduced to permit the employers of first responder personnel to obtain dementia training.

- **HB1107 Relating to Computer Crime**, a bill I introduced which adds aggravated harassment by stalking to the list of offenses upon use of a computer.

A Message From COUNCILMEMBER HEIDI TSUNEYOSHI

Aloha,

Throughout my time as Councilmember and Staff of the District 2 office, it has been my honor to serve Mililani for more than a decade and I thank the Mililani Town Association for the opportunity to provide an update of what has been going on at the City Council.

I continue to have strong concerns regarding the Honolulu rail project as over the last year we learned we are facing a \$3 billion shortfall with no sources to fill that gap. With the Federal and State governments already facing their own budget constraints due to the pandemic, we are in a dire situation. For this reason, I introduced Resolution 21-116, which requests the City to institute an interim terminus at Middle Street until suitable funding sources are secured. My position has always been that we cannot build the rail system if it puts an undue financial burden on current and future taxpayers. Because we are reaching a point where we are settling our financial obligations, I felt that before we enter into any new contracts, we need to figure out how we are going to pay for the entirety of the project.

In March, our north shore and windward communities were inundated by heavy rainfall and flooding. This revealed issues with stream maintenance and if the State and City were doing their parts in ensuring the clear flow of our waterways. To this end, I introduced Resolution 21-77, which requested the city administration to develop a stream maintenance schedule for City-owned streams and non-stream drainage infrastructure. In addition, I requested for \$5 million to develop a stream maintenance program. With this, I feel our island will be more prepared in the event of another flood event, giving residents some security with regard to their residence or business.

Much of my council district is made up of coastal communities so I have a lot of respect and admiration for our Ocean Safety Division and the lifeguards who risk their lives to protect our residents and tourists. For many years, lifeguards have been underrepresented. I introduced Resolution 21-122 which urges the Mayor to create a separate department for the City's Ocean Safety Division to provide the autonomy they need. Currently, our watermen fall under the Honolulu Emergency Services Department (HESD), but as an independent agency, lifeguards will have a greater voice in prioritizing their objectives as well as the flexibility of maintaining its own budget. This is a win-win as HESD would be able to focus on transitioning its operations and funding from the State to the City and Ocean Safety would gain the independence they desire. With the ever-changing landscape of ocean safety, in conjunction with higher visitor numbers, we

need to ensure that Ocean Safety has all the resources it needs to effectively protect our residents and visitors.

For the upcoming fiscal year, we have many projects for Mililani Mauka. The City's continuing Rehabilitation of Streets project will be addressing many roads in Mililani Mauka, including much needed improvements for Makaikai Street from Meheula Parkway to Kuhea Street. City crews have been filling potholes in February and March and with the upcoming repaving, Makaikai Street should be free of potholes for the near future. The sidewalk along Makaikai Street has been also been scheduled for maintenance. I reappropriated funding for improvements to Mililani Mauka District Park which would include the construction of a new tennis court and installation of a field lighting system. I also included funding for an extension to the Mililani Mauka Dog Park which would create a separate area for small dog breeds.

For ongoing Mililani Mauka projects, the play apparatus at Mililani Mauka District Park is scheduled for installation and the construction bid is pending. Construction of the LED lighting solution at the Mililani Park and Ride is ongoing with a majority of the lighting equipment being replaced. The old lights were highly deteriorated so we worked with the Department of Transportation Services to have new lights installed. We also requested that the parking stalls be repainted and the overgrowth in the empty lot be landscaped.

Finally, the City Council adopted the Central Oahu Sustainable Communities Plan, which guides the development of Central Oahu communities, including Mililani. This plan ensures prime agricultural lands in Kunia, Waipio, Wahiawa and Mililani will only be used for agricultural purposes and prohibit any development outside of the boundary line. Thank you to the many individuals and organizations who advocated and gave their time to ensure their communities' voices were heard and represented in this plan.

A Message From COUNCILMEMBER AUGIE TULBA

Aloha! As your new City Councilmember, I'm ready to meet and hear from you so I can better understand the issues affecting your daily life. Our district, Council District 9, covers Waialeale, Village Park, Royal Kunia, Mililani Town, West Loch, Iroquois Point, and portions of Ewa Villages and Ewa Beach. My staff and I are dedicated to serving our community and connecting our district to the resources we need for our neighborhoods to be safe and thriving.

The COVID-19 pandemic has given us unique challenges. From keiki to kupuna, every person continues to be impacted. We must continue to work together so we can cooperatively make progress in caring for our parks, our streets, and our community. My goal is to represent District 9 at Honolulu Hale and to keep you informed of the issues and projects being discussed at the City Council. As an incoming freshman member, I'm excited to be appointed to serve as the Committee Chair for Parks and Community Service, and the Vice Chair for Public Safety. I will also be a voting member on the three other committees: (1) Housing and the Economy, (2) Executive Matters and Legal Affairs, and (3) Transportation, Sustainability, and Health.

Because of the pandemic, the City Council has limited in-person attendance at meetings, but there are still ways you can stay engaged. The City Council has an interactive website that provides live streaming and archives all Council meetings and agendas. Please visit the website at www.honolulucitycouncil.com. You can also find links to submit testimony, the council calendar, and committee information.

From stream maintenance to the Honolulu Rail Transit Project, the Honolulu City Council has been discussing a range of legislative issues affecting our City. Here are measures that have been recently considered by the Council:

Bill 1 (2021) Allows the City and County of Honolulu to award incentive grants to developers of qualifying affordable housing projects. Status: Bill passed Third Reading on April 14, 2021 and approved by the Mayor on April 22, 2021.

Bill 18 (2021) Requires notice on certain roadways near the entrance of hiking trails warning that parking is prohibited in front of a public or private driveway or within four feet of either side of a public or private driveway. Status: Bill passed Second Reading on May 5, 2021 and referred to committee.

Bill 87 (2020) Proposes a fare increase for all paratransit riders from \$2.00 to \$2.25. Status:

Bill passed Third Reading on May 5, 2021 and approved by the Mayor on May 14, 2021.

Resolution 21-34 Urges increased flexibility for electronic participation in and public access to meetings of City and County of Honolulu boards and commissions, city council, and other city agencies to increase and assure effective citizen participation. Status: Resolution adopted by the City Council on February 17, 2021.

Resolution 20-144 Authorizes the Director of Budget and Fiscal Services to issue and sell in one or more series not to exceed \$26,000,000 principal amount of general obligation bonds of the City and County of Honolulu for financing capital costs of the Honolulu Rail Transit Project. Status: Resolution adopted by the City Council on March 17, 2021.

Resolution 21-77 Requests that the City Administration develop a stream maintenance schedule for City-owned streams and non-stream drainage infrastructure. Status: Resolution adopted by the City Council on May 5, 2021.

Resolution 20-338 Urges the City Administration and the Hawaii Department of Land and Natural Resources to enter into an agreement establishing a procedure for the cooperative removal and disposition of vessels abandoned on city roads and rights-of-way. Status: Resolution adopted by the City Council on February 17, 2021.

My staff and I are also learning about the City Budget. From March to June, the Council reviews and deliberates on the proposed budget package from the Mayor. The Council must adopt a budget by June 15. Within 10 days of the Council's adoption, the Mayor must either sign the bills, return the bills unsigned, or veto the budget bills. The Council may override the veto with a 2/3 vote. For tracking, here are the budget bills before the Council:

- Bill 5 (2021) Legislative Budget for FY 2022
- Bill 6 (2021) Executive Operating Budget for FY 2022
- Bill 7 (2021) Executive Capital Budget for FY 2022
- Bill 12 (2021) HART Operating Budget for FY 2022
- Bill 13 (2021) HART Capital Budget for FY 2022

I'm learning so much already and I can't wait to share my experiences with you. District 9 is diverse in many ways, and my team and I are hopeful we can bring people together to do what's best for our community. 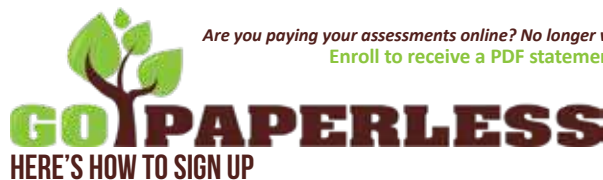
HOMEOWNER ASSESSMENTS

The MTA quarterly assessment is collected in accordance with Article VI, Section 6.02 of the Mililani Town DCCR. Assessment due dates are January 1st, April 1st, July 1st, and October 1st in the amount of \$125.00 per quarter (effective April 1, 2020). Quarterly reminder notices are sent to homeowners. A \$10.00 late fee will be charged if payment is not received by the 10th of the month that payment is due.

THERE ARE 5 WAYS TO PAY YOUR ASSESSMENTS:

1. SurePay Payment Plan - SurePay allows your bank to automatically, electronically transfer your quarterly assessment payments from your checking or savings account through Automated Clearing House (ACH) to MTA. Fill out a SurePay form and turn it in to one of our business offices or send it to surepay@mililantown.org. Submit a voided check with your form.

4. Use Our Secure Drop-Box - There is a drop-box located inside the administration office and is only available during regular business hours. **(Currently Unavailable: please bring your payment to the Rec 3 or 7 Business Offices).**

5. Pay by Mail - To avoid late fees, please allow ample time for mail delivery and for your

payments to post as received. Homeowners with multiple properties must submit a separate remittance stub and payment, for each property address.

- If you are mailing a check with the remittance stub, please mail it to: Mililani Town Association, P.O. Box 29380, Honolulu, HI 96820-1780. This is a "Lockbox" service through Bank of Hawaii. Only the payment will be processed.

DECLARE YOUR Financial Freedom

Independence Day is almost here. And as we make progress in moving past the COVID-19 pandemic, more of us will be able to enjoy Fourth of July activities. However you observe the holiday, it's important to recognize all the liberties we enjoy in this country. But you may still need to work at one particular type of freedom – and that's financial freedom. How can you achieve it?

There's no one instant solution. But you can work toward financial independence by addressing these areas:

- Retirement savings – Approximately 45% of Americans think the ideal retirement involves "enjoying my well-earned freedom"; according to the March 2021 Edward Jones/Age Wave Four Pillars of the New Retirement study. But when you're retired, the risk to this freedom is obvious – the paychecks have stopped but the bills haven't. Furthermore, you could spend two or three decades in retirement. That's why it's so important to contribute as much as you can afford to your tax-advantaged retirement accounts, such as your IRA and your 401(k) or another employer-sponsored plan. At a minimum, put in enough to earn your employer's matching contribution, if one is offered. Whenever your salary goes up, try to increase the annual amount you put in your 401(k) or similar plan. And if appropriate, make sure you have a reasonable percentage of growth-oriented investments within your 401(k) and IRA. Most people don't "max out" on their IRA and 401(k) each year, but, if you can consistently afford to do so, and you still have money you could invest, you may want to explore other retirement savings vehicles.

- Illness or injury – If you were to become seriously ill or sustain a significant injury and you couldn't work for an extended period, the loss of income could jeopardize your ability to achieve financial independence. Your employer may offer disability insurance as an employee benefit, but this coverage is typically quite limited, both in duration and in the amount of income being replaced. Consequently, you may want to consider purchasing private disability insurance. Keep in mind that this coverage, also, will have an end date and it probably won't replace all the income lost while you're out of work, but it will likely be more expensive and generous than the plan provided by your employer.

- Long-term care – Individuals turning 65 have about a 70% chance of eventually needing some type of long-term care, such as a nursing home stay or the assistance of a home health aide, according to the U.S. Department of Health and Human Services. And these services are quite expensive – the average annual cost for a private room in a nursing home is more than \$100,000, according to Genworth, an insurance company. Medicare typically covers only a small part of these expenses, so, to avoid depleting your savings and investments (and possibly subjecting your grown children to a financial burden), you may want to consider long-term care insurance or life insurance with a long-term care component. A financial advisor can help you choose a plan that's appropriate for your needs.

By addressing these areas, you can go a long way toward attaining your financial independence. It will be a long-term pursuit, but the end goal is worth it.

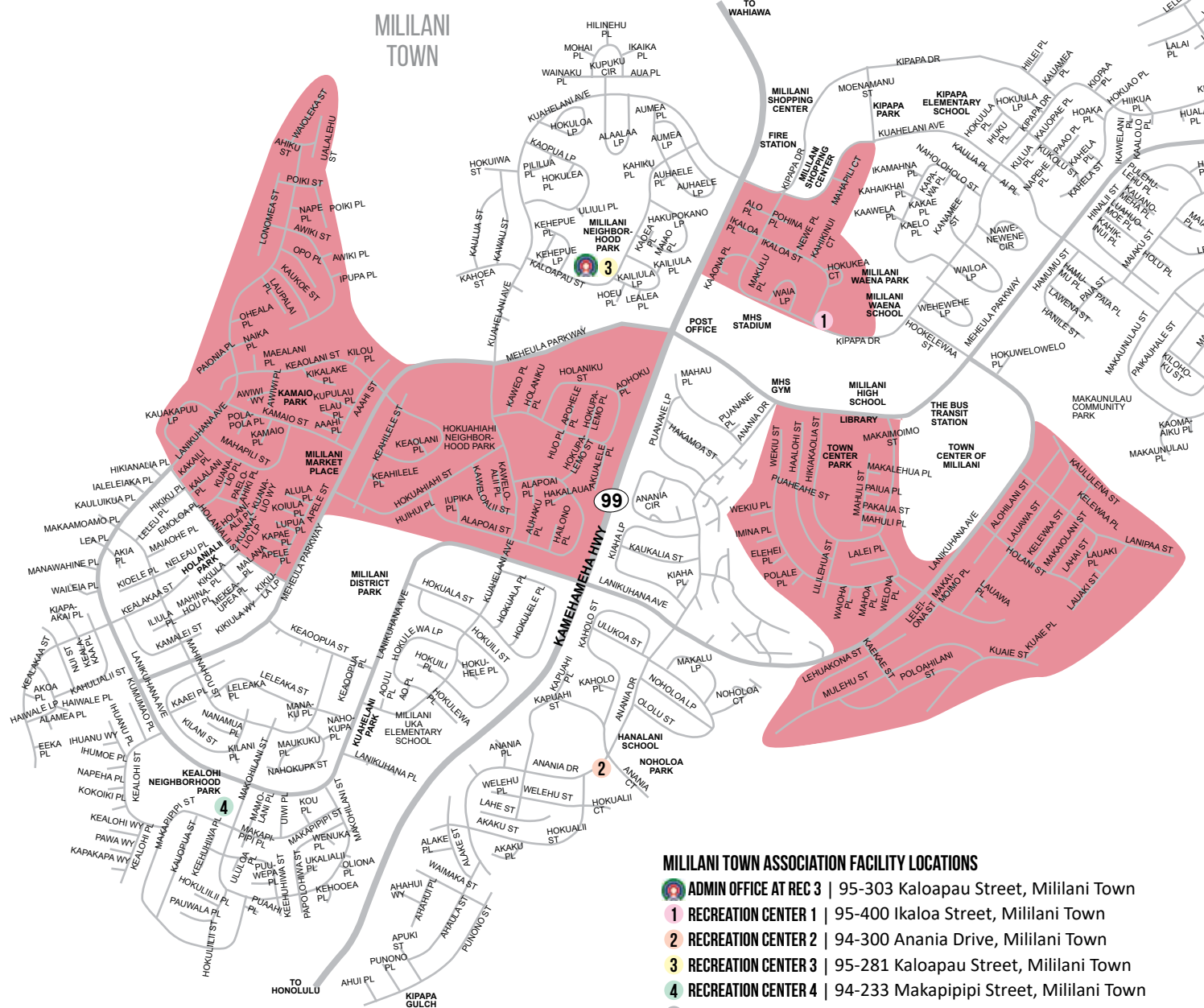

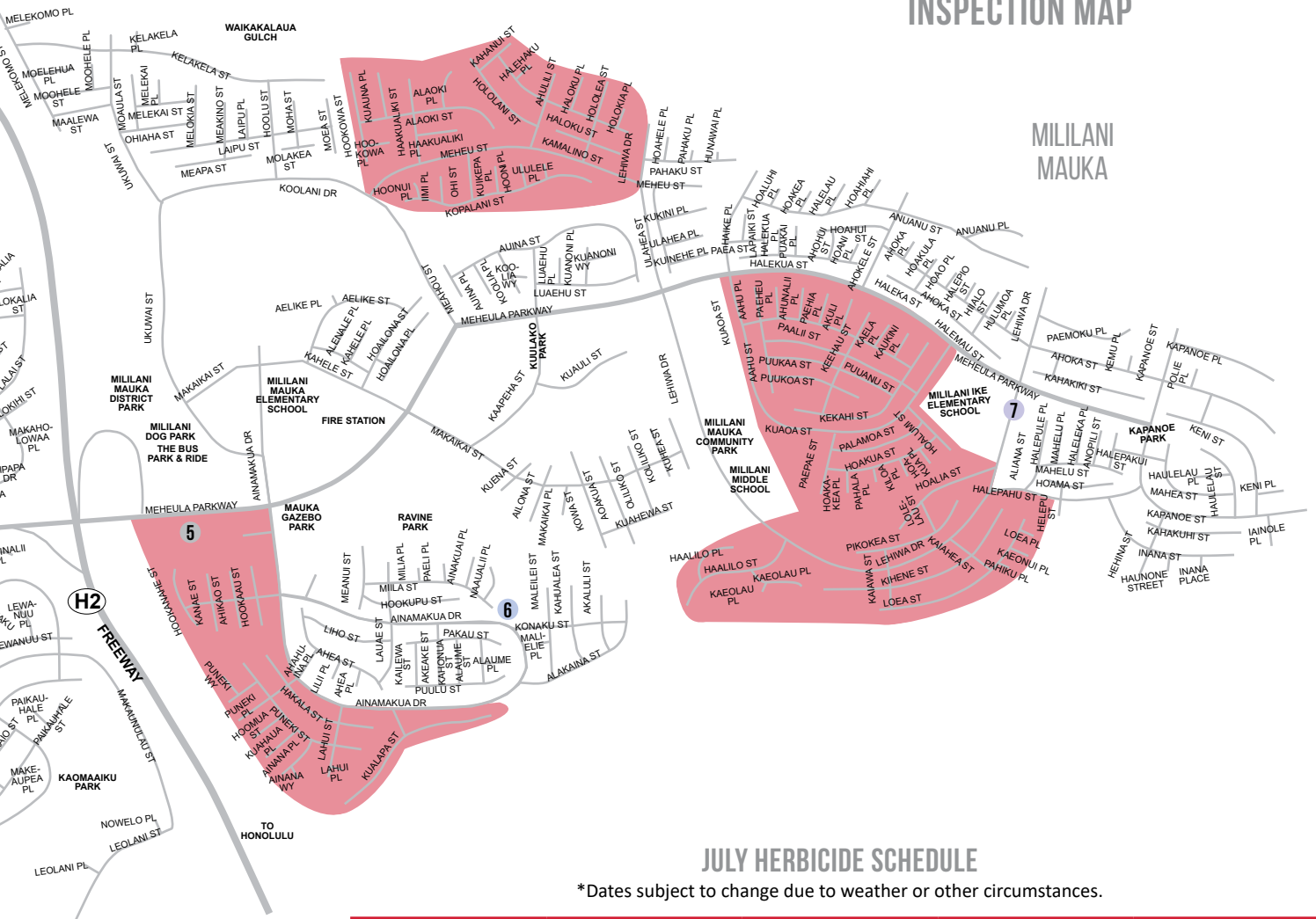
