# PRESIDENT'S MESSAGE



Happy July Mililani! I hope you are enjoying your summer so far!

With Summer in full swing - as you may know, our MTA Lifeguards are trained and certified in Basic Life Support (BLS) skills, which include cardiopulmonary resuscitation (CPR) and other lifesaving skills required to help keep our members safe while using our pools, Rec Centers, and other MTA facilities. Proper training and swift response are important in an emergency and can increase the chance of survival if someone has a cardiac arrest. This can happen anywhere. This hit home for me all too recently when I found out a good friend of mine had collapsed a few weeks ago while doing some yard work around his Mililani home. Thankfully, his oldest son (their family's four adult children have all been MTA Lifeguards in the past) just happened to be

home when it happened. His previous lifeguard training not only helped keep him calm, but he was able to administer CPR until the EMTs could arrive and rush his dad to the hospital. Though my friend is not out of the woods yet, he is on the road to recovery. Thank you to his son and thank you to MTA for training our lifeguards so well!

While rescue and healthcare professionals require a higher level of training, ANYONE can help save a life by learning Hands-Only CPR and by using an AED! Did you know MTA also has an AED (Automated External Defibrillator) at every Rec Center? These easy-to-use devices (just turn it on and follow the directions) can be used to increase the chance of survival for cardiac arrest victims at home, at work, at the park – anywhere!

You will notice the "Mililani Town Association Aloha Pledge" printed in this newsletter this month (see far right). This is something we adopted at a previous board meeting. The intention of this Aloha Pledge is to try and make interactions with each other more meaningful and pleasant, both in person and online. This is being discussed with community associations nationwide. Your Mililani Town Association staff and board are going to make a conscious effort to live up to this pledge when we are interacting with you, and we are asking you to keep it in mind when you are working with us. For me, I am going to try to apply these principles everywhere, all the time. I can always do better.

# **MESSAGES FROM ELECTED OFFICIALS**

### A Message From SENATOR DONOVAN M. DELA CRUZ

### Aloha,

Mahalo for all your support for this legislative session. The legislature officially adjourned on May 4, 2023. As always, lawmakers and I pushed hard to pass key priority bills for Hawaii's working families and the constituents of District 17 to alleviate the challenges caused by the state's high cost of living. The following highlights are bills that passed the legislature this year:

### HB954

 Provides a generous expansion of the state's food excise, child and dependent care, and earned income tax credits

### SB821

 Provides \$1.25M to the Department of Law Enforcement to create the Illegal Fireworks Task Force

• The purpose of this task force is to create a strategic plan to stop the illegal importation of fireworks and explosives into Hawaii

### SB833

 Provides \$26M to the Department of Agriculture to purchase and renovate the Wahiawa Irrigation to meet safety standards
 The Wahiawa Irrigation system plays a major role for agriculture in Wahiawa, Waialua, and Haleiwa

### HB1004

• Provides \$187M to increase teacher salaries

### HB600

 Provides \$10M to the Department of Transportation to develop a comprehensive plan to improve safety of keiki and families commuting to school

The Legislature also passed HB300 which is a \$21.7 billion executive budget. The priorities of the senate in HB300 were to address the needs of lower and middle-class residents, quality of life for teachers, and the impacts of climate change. This measure contains key funding such as:

- •\$18M for a new admin building for Leilehua High School

- \$3.6M for Hugh Yoshida Stadium renovations
- \$200,000 for the Cybersecurity Academy at Leilehua High School

- $\bullet$  \$3.4M for a covered play court at Wahiawa Elementary School

- \$6.6M for an increase of Child Protective Service contracts
- \$12.6M for nursing facilities

- \$20.4M Based Service Waiver for individuals with intellectual and developmental disabilities
- \$91.2M for Emergency Medical Services across the State
- \$15M for the Ohana Zones Pilot Program
- \$48M for Kauhales across the State

### HOUSING

- \$170M for teacher workforce housing
- \$6M for Rent supplement assistance for middle-income families
- \$3.2M for First-To-Work Housing Assistance
- \$7.4M for Housing First Program
- \$7.4M for Rapid Re-Housing Program
- \$100M for DURF Loans and infrastructure projects

• \$280M for Rental Housing Revolving Fund for low-income individuals and families

• \$33M to support the most vulnerable and chronically homeless

HB300 has now been transmitted to Governor Josh Green for his signature.

### A Message From SENATOR MICHELLE KIDANI

### Aloha Friends and Neighbors,

It has been a busy but productive few months since the close of the 2023 legislative session. I attended many graduations and other events within the district in Mililani, Waipahu and Pearl City to congratulate students as they celebrated the end of the school year. I am so grateful for the hard work of our dedicated DOE faculty, staff and administration who support their successes. I was also pleased to attend assemblies at Kipapa, Mililani Uka, and Mililani Waena Elementary schools, and provided certificates for several students at Mililani Middle School as well. I enjoy the opportunity to present certificates to the student recipients of 2023 Kidani awards and to celebrate

#### with their school communities.

The end of the session is always a time of reflection for me to look back on the work we have accomplished. By now you may have received my End of Session newsletters which were mailed to the home addresses of constituents in Senate District 18. I included in these newsletters a comprehensive breakdown of bills that passed this year, a list of Capital Improvement Projects (CIP) in schools that the Senate was able to secure, as well as a budget breakdown of the 2023 session. I am excited to share three recent developments in education funding that will help provide Hawai'i's students with greater opportunities to improve their learning environment, as well as additional support for our hard-working teachers:

### SB941 SD2 HD1 CD1: RELATING TO THE SCHOOL FACILITIES AUTHORITY

This bill appropriates \$170M for teacher housing and classroom development. We are all painfully aware of how expensive it is to live in Hawai'i. This funding will help provide affordable housing options for teachers, making it easier for them to stay in the state and continue providing quality education to our children. Funding will also be used to improve classroom facilities, creating an early start and a more conducive learning environment for students.

### HB960 HD1 SD2 CD1: RELATING TO THE SCHOOL FACILITIES AUTHORITY

This bill appropriates \$200M to construct new school facilities as well as to renovate, improve, and expand existing school facilities to increase pre-k student capacity. This funding will help to address the overcrowding issues that many schools in Hawai'i are facing, ensuring our children have adequate space to learn and grow. It will also help to modernize our schools, providing students with the tools they need to succeed in the 21st century.

#### HB1004: RELATING TO PUBLIC EMPLOYMENT COST ITEMS

This bill includes a four-year contract with \$577M in funding for Bargaining Unit 05 teachers of the Hawai'i State Department of Education (HIDOE) and public charter schools. This bill includes \$187M covering salaries and fringe benefits for the next two years. Our teachers work hard every day to provide our children with the education they need to succeed, and it is only fair that they receive the compensation they deserve. This funding will help to attract and retain the best and brightest teachers, ensuring our children continue receiving a quality education from well-compensated educators.

These bills demonstrate a significant investment in Hawai'i's education system, and as the Chair of the Senate Committee on Education, I am proud of the strides they represent. They will help to provide our children with well-needed resources and to support our teachers in providing students the best education possible. I am confident these developments will have a positive impact on our communities, our economy, and most importantly, our children's future.

Additionally, here are a few noteworthy Mililani Capital Improvement Project (CIP) highlights for our district schools: • \$6M for the design and construction of a covered court at Mililani High School. This covered court will be used as secondary gym space and for community farmers market events.

 \$2.5M for the design and construction of a new covered play court at Kipapa Elementary School.

• \$1.6M for the design and construction of cafeteria air conditioning at Kipapa Elementary School.

In closing, I'd like to send my aloha and congratulations to our Mililani High School graduates! It was heartwarming to celebrate at the Stan Sheriff Center as we cheered on the accomplishments of 608 seniors, including 98 Valedictorians, 163 Summa Cum Laude, 98 Magna Cum Laude, 131 Cum Laude, 208 Academic Honors certificates, 284 CTE Honors certificates, 6 STEM Honors certificates, 11 AP Capstone completions and 23 Seal of Biliteracy recipients, as well as over \$30.2M in merit-based scholarships and countless other awards. The success of these students is a testament to their dedication to their studies and the collective support of their families, teachers and staff. Congratulations to the Mililani High School class of 2023! Your hard work, tenacity and brilliance are invaluable qualities which will serve you well in your future pursuits. Best wishes to you all in your future endeavors—Hail, Hail!

### A Message From REPRESENTATIVE TRISH LA CHICA

Dear Mililani Neighbors,

I am humbled by the opportunity to serve as your Representative in the State Legislature, representing District 37, encompassing Mililani Town, Mililani Mauka, Waipio Gentry, and Koa Ridge.

In February, Governor Green appointed me to the House of Representatives following the resignation of Representative Ryan Yamane, who assumed a position as the Deputy Director for the Department of Human Resources Development. The House seat remained vacant for a month and a half during the vetting and nomination process before the Governor made his decision. I must admit that the waiting period was quite nerveracking. Then, on February 14, I received a FaceTime call from the Governor.

Governor Green: "I have a Valentine's present for you. How would you like to serve in the House of Representatives?" Me: "Really? (I was taken aback.) OMG YES! YES! THANK YOU!!"

The next few weeks were a whirlwind. I had to quickly hire staff, set up my office, familiarize myself with legislative procedures and floor protocol, and read up on approximately 400 bills that were up for third reading in the House. It was a demanding period, and I am grateful to my husband's support in caring for our kids while I devoted myself to this work (and many late nights).

Over the next few months, we met with advocates, promptly responded to constituent requests, drafted and introduced resolutions (all of which passed!), and built relationships with my colleagues and the community. During recess days, my staff and I had the opportunity to be in the district, meeting with residents, school principals, community policing teams, and local business owners.

The resolutions I introduced were directly inspired by the community, calling for action on various topics. Some of these included raised crosswalks along Meheula Parkway, expanding social service outreach to homeless populations in Central Honolulu, supporting small businesses through the establishment of business improvement districts, and creating additional transit routes between Central Oahu and the Waiawa rail station. Currently, we are following up with the various state and city agencies to ensure they take the necessary actions.

I am also delighted to report on the funding we have secured for our district:

• \$550,000 for Kanoelani Elementary for bathroom facilities for special education students.

 \$6,000,000 for Mililani High School for a multipurpose covered playcourt, benefiting the students' culinary and robotics programs, as well as providing a community space (e.g., farmers market).

 \$200,000 in GIA funding for Achieve Zero, to continue serving over 600 individuals experiencing homelessness from Central Oahu to the North Shore.

• \$150,000 in GIA funding for Aloha Harvest to establish a food resiliency and emergency response hub in Central Oahu.

 \$500,000 in GIA funding for Wahiawa Center for Community Health to address the growing mental health needs of our student population in the Leilehua/Mililani/Waialua School Complex area.
 \$260,000 in GIA funding for renovation needs at the Hawaii United Okinawa Association.

These projects, alongside others secured by our area legislators, are part of the HB300 budget, which is currently under review by the Governor and his team. We will provide a final community update on bills and the budget in our July newsletter.

Our office takes great pride in promptly responding to every call, email, and letter we receive. Over the last few months, we have assisted constituents with a wide range of requests, including road repairs, pedestrian safety concerns, public assistance benefits, property management and landlord assistance, and even maintaining the grass along Kamehameha Highway. One notable achievement was our involvement in reopening the Mililani outdoor hockey rink near 10 Acres Park. I extend my gratitude to the City's Parks and Recreation Department, and the Mayor and his team for making this facility available for our children and families to enjoy.

Now that the legislative session has concluded, I have more time to spend here in our community, visiting areas of concern, conducting outreach, and hosting community events. Our upcoming town halls will focus on public safety and rail, so please sign up for newsletter updates from my office by visiting www.reptrishlachica.com.

As challenging and hectic as this work can be at times, I genuinely love what I do. This is my first term so there is always much to learn and plenty of work ahead, but I am committed to improving our communities and representing Mililani and Waipio in the legislature. While my immediate priorities focus on public safety and transit, I am also passionate about addressing housing, education, health, and creating economic opportunities. All of the bills that were submitted in the beginning 2023 and have passed every committee as well as a final floor vote are now on the Governor's desk waiting to be signed and enacted into law. Mahalo for reaching out to my office to express your support or opposition to active bills and thank you to those who formally submitted testimonies during the legislative process this year. Please continue to contact me during the interim as we prepare and research legislation to introduce next year.

If you live in District 38 you will be receiving my legislative session wrap-up newsletter in the mail if you haven't already. This newsletter will include updates on the bills that have passed this year, share constituent survey responses, and highlight community updates.

A special highlight for me this past session was honoring the athletic achievements of the many student athletes at Mililani High School in March. At that point in the year, Mililani teams won 19 OIA championships and had several Individual State Champions. Over 150 athletes along with their parents, coaches and administrators came to the capitol where we honored each athlete with a certificate on behalf of the Hawaii State Legislature. I cannot begin to express how proud I am of my Alma mater. As a former Trojan athlete myself playing volleyball, swimming and water polo, I know how much time and dedication it takes to not only participate in athletics but even more so to win championships!

During this legislative session, we had two High School students (Vincent Wilson, a Junior at Mililani High School and Diego Caranza a Senior at Leilehua High School) and one College student (Hunter Harris, a Sophomore at Chaminade) join my office as interns. All of these impressive interns were vital additions to our team this year and I cannot speak enough about how proud I am to see them succeed. It is students like them that make me so excited for our community and hopeful for the future of Hawaii.

If your child or someone you know is interested in an internship with my office, please encourage them to apply. Our Capitol internships are open to all High School Juniors and Seniors as well as College students of any level. The internship provides a unique opportunity to work with a legislator in the House of Representatives - giving students insight into our local legislative process and how we work to improve our community, district, and state. The Hawaii State Legislative Session takes place between January and May every year. Legislative Internships will begin on the first day of the Legislative Session in January and conclude in May. ### A Message From COUNCILMEMBER VAL AQUINO OKIMOTO

Aloha kakou! I hope this message finds you all well. As many of you know I was recently elected to the Honolulu City Council in November to proudly serve the constituents of District 8. It is my absolute honor and pleasure to provide you all with my first legislative update from the City Council.

My team and I have been diligently working as the City continues its discussions on the City's Operating and Capital Improvement budgets. Here is a brief summary of the City's FY24 budget. The projected operating resources for FY24 total \$3.91 billion, reflect higher overall revenues and carryover as the recovery from the COVID-19 pandemic downturn continues. The City's largest revenue source, real property taxes, is estimated at \$1.67 billion, or 42.38% of operating resources. The FY24 proposed budget includes a \$300 real property tax credit for homeowners, in order to mitigate the effects of the unusual increase in assessed valuations for residential properties. The deadline for the Council to approve the budget is June 15.

Aside from the budget the City has been taking up numerous resolutions to address Oahu's critical housing shortage. Resolution 23-58 is a 139 unit building, located at the former Aiea Sugar Mill, with affordable studio and one-bedroom rentals to individuals 62 years or older and whose household income is 60% or below the area median income (AMI). Resolution 23-59 is a 158 unit building consisting of studio and one to four-bedroom rental units to be rented to households earning 60% or below of the AMI. Resolution 23-60 is a 222 unit building that will also have affordable studios and one to four-bedroom rental units to be rented to households earning 60% AMI. Both of these projects will be in Kapolei. I look forward to working with our communities and local developers to continue to bring more affordable housing options to Oahu.

For our community updates, we have received numerous calls regarding overgrown grass at various City parks, including the Mauka Park and Ride. We were able to work with the Department of Parks and Recreation (DPR) in order to help maintain the overgrown grass, allowing athletic teams to once again utilize the fields. My office and I also had the pleasure of meeting with DPR and the Council for Native Hawaiian Advancement, to look at long term solutions and ways we could best utilize the vacant area at the Mauka Park and Ride, in order to benefit our community.

I would like to take the time to recognize some accomplishments achieved by the youth in our community. Congratulations to the Hawaii Inline Hockey Incorporation on bringing home the Gold and Silver medals from the Torhs Tournament in San Jose, CA. My team and I look forward to working with you in bringing much needed support and resources to the Hockey Rink.

Special shout out to our MHS Trojans Athletics Department! This school year our Mighty Trojans were able to capture a multitude of OIA Team Championships. Congratulations to the following teams: Golf Girls' Varsity, Tennis Girls' Varsity, Track Girls' Varsity, Track Girls' Varsity and JV, Cross Country Boys' Varsity, Softball Girls' JV, Soft Tennis Girls' Varsity, Volleyball Girls' JV, Soccer Girls' Varsity and JV, Soccer Boys' Varsity and JV, Swimming Boys' Varsity and Girls' Varsity and JV. Thank you for your amazing accomplishments and for representing our school and community so proudly! Mahalo also to the coaches and parents/ family who have supported our student athletes in their journeys to these championship titles.

Lastly, congratulations to our 2023 Mililani graduates! You have experienced and endured much, and have come out stronger for it. This has allowed you to develop and grow your understanding of the world. Your perseverance and devotion will be rewarded with a bright future! I am grateful to have been able to share in that momentous graduation ceremony with you. While graduation may seem like the end of an era, it is actually the beginning of a bigger and brighter future! Please be sure to give your parents, family, teachers, and friends a huge hug for all their love and support these many years! As you take the next steps in life, always remember to stay true to who you are, live each day with principle and passion, and maintain integrity regardless of where you are at. Even if you at times have to stand alone. Always remember that you are one of "the Mighty Trojans, the brave and the bold, Blue skies above, clear as can be. Hail, hail, hail!" I wish you the very best in your future endeavors!

# HOMEOWNER ASSESSMENTS

The MTA quarterly assessment is collected in accordance with Article VI, Section 6.02 of the Mililani Town DCCR. Assessment due dates are January 1st, April 1st, July 1st, and October 1st in the amount of \$145.00 per quarter (effective April 1, 2022). Quarterly reminder notices are sent to homeowners. A \$10.00 late fee will be charged if payment is not received by the 10th of the month that payment is due.

### THERE ARE 5 WAYS TO PAY YOUR ASSESSMENTS:

 SurePay Payment Plan - SurePay allows your bank to automatically, electronically transfer your quarterly assessment payments from your checking or savings account through Automated Clearing House (ACH) to MTA. # **IMPORTANT NOTICE: RULES AND ENFORCEMENT AT OUR FACILITIES**

Parents and Guardians, we need your help. We have seen an increase of our MTA staff issuing warnings to school aged members at our recreation centers. Warnings include use of profane language, bullying other members, running and screaming in the facilities, not cleaning up after themselves (example: leaving empty saimin bowls and drinks in the facility), abuse of MTA recreation equipment, roughhousing and "bombing" in the pools. MTA staff are instructed to give two warnings. The third warning will result in being ejected from the premises and parents being called. This is a daily routine for MTA staff, especially at Recreation Center 7.

### PARENTS/GUARDIANS: PLEASE SPEAK TO YOUR CHILDREN WHEN SENDING THEM OR DROPPING THEM OFF AT THE FACILITIES.

### Per the Mililani Town Rules

Section C-8: "Any person using the facilities agrees to abide by the MILILANI TOWN RULES and instructions of MTA Staff on duty as a condition of remaining on the premises."

Section J-1: "Violation of any of the MILILANI TOWN RULES while using any of the Mililani Recreation Centers will result in two verbal warnings before being ejected from the premises. The individual will be refused Recreation Center use privileges for a period of 48 hours. Any activity that is dangerous to an individual or others and/or illegal will not require any warning and will result in immediate ejection from the premises. (If the individual refuses to vacate the premises as requested, HPD will be summoned, and the violator charged with 'trespassing')".

Section J-4: "Any repetition of the same violation will not require warning before being ejected from the premises. Additional penalties imposed may be more severe including, but not limited to, suspension of all privileges for a longer period as determined by the General Manager".


# MONTHLY COVENANTS INSPECTIONS
